


Plan vs. Performance

This note lists the legislative business planned by Parliament and compares it with the actual performance during Winter Session 2019.

Both Houses of Parliament sat late on several days. Bills such as the Citizenship (Amendment) Bill, 2019, and the Taxation Laws (Amendment) Bill, 2019 were passed after more than seven hours of discussion. Both Houses discussed issues related to air pollution. Rajya Sabha also discussed the state of the economy. Lok Sabha discussed and passed the first supplementary demand for grants.

17 legislative Bills were introduced and 14 were passed excluding an Appropriation Bill to approve the supplementary demands for grants. Lok Sabha worked 111% and Rajya Sabha worked 92% more than the scheduled time.
