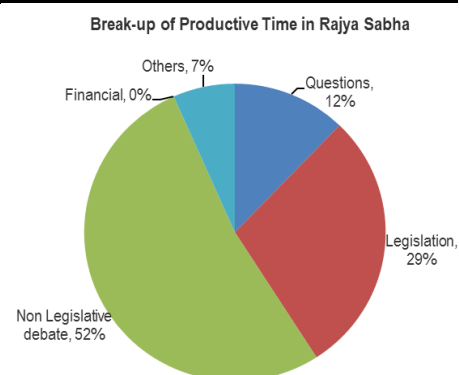
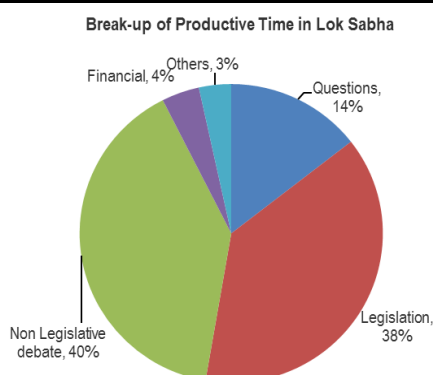


Plan vs. Performance

The Monsoon Session of Parliament adjourned *sine die* on August 12, 2016. Both the Houses discussed issues related to inflation, violence in Kashmir and atrocities on Dalits in the country. Discussions on sustainable development goals and the draft education policy 2016 were held in Lok Sabha and Rajya Sabha respectively. Supplementary Demands for Grants (Appropriation Bill) was passed by both houses but discussed only in Lok Sabha.

14 legislative Bills were introduced during the Session and one was withdrawn. 14 legislative Bills were passed by Parliament while four were passed by only one House. Lok Sabha worked for 101% of the scheduled hours and Rajya Sabha for 96%.
